2022-23 A YEAR OF ADVENTURE

BOEC served 2,136 participants over 5,882 program days in 2022-23. Longtime partners returned, and new partners joined us to experience the outdoors with BOEC for both winter and summer programs.

In 2022-23 BOEC awarded close to \$250K in scholarships. All qualified applicants who requested financial assistance were granted scholarships.

Adaptive Ski and Snowboard Program

The Adaptive Ski and Snowboard Program thrived providing 2,920 lessons to groups and individuals between Breckenridge, Keystone, and Copper Mountain resorts. This marked an increase of more than 300 lessons from the previous season, serving 977 unique individuals. This year we added more opportunities for staff training and will continue to evaluate and provide continuing education for our staff. We celebrated Ski Program Director Jeff Inouye's induction into the Adaptive Sports Hall of Fame celebrating 30 years of contributions to the adaptive ski and snowboard industry. New ski program uniforms were introduced for the 2022-23 winter season continuing the tradition of green jackets. Sponsors supporting this project include FirstBank, CommonSpirit Health, Rockridge Construction, and Blue River Sports/Mountain Wave.

Wilderness Program

The Wilderness Program led 84 courses serving 1,159 students over 2,962 program days. The team continued to focus on improving infrastructure and undertaking capital projects to protect and preserve the Wilderness Campus. Jaime Overmyer, Wilderness Program Director, celebrated 20 years with the BOEC. New groups this summer included The Woods Project from Houston, Texas, the Craig Hospital CHILL program, and the Breckenridge Recreation Center's climbing program, bringing a diverse range of abilities, ages and backgrounds to the BOEC. To ensure the smooth operation of programming and offer extra transportation support for concurrent Wilderness courses, a new truck was incorporated into the vehicle fleet. A new raft was donated by the Estate of Dan Grover adding to BOEC's robust rafting operations.

Therefore a second seco

Fifteen interns joined the winter internship class, and ten during the summer, coming to BOEC to learn about outdoor experiential education. New marketing efforts were introduced significantly increasing the number of applications and making the program more competitive. The BOEC Internship Program is non-revenue generating and relies on the support of generous donors to ensure sustainability. The Moniker Foundation supported the cost of this important program for the fifth year.

Volunteer Program

With a total of 275 active volunteers, including 122 newcomers and 37 military veterans, the volunteer program reached new heights by contributing a collective 15,320 hours to support BOEC's Adaptive Ski and Snowboard Program lessons. Over the summer, 45 active volunteers dedicated a total of 1,084 hours to Wilderness programming. The entire BOEC volunteer base is nearly 500 individuals strong.

🖀 Heroic Military Program

This program served 185 military members and their families through year round programming. The Wilderness Program implemented several rafting trips and mountain retreats, while the Adaptive Ski and Snowboard Program provided over 250 lessons to military veterans and their families. BOEC continued collaboration with Craig Hospital's Operation TBI Freedom, Telluride Adaptive Sports Program, Adaptive Adventures, The Not Forgotten from the UK and Team Semper Fi & America's Fund. The Heroic Military Program received generous funding from the Department of Veteran Affairs and our Circle of Support partners Limber Grove and First Nation Group.

Prink Fundraising and Events

BOEC was supported by 720 individual, foundation, government, and corporate contributors who helped us surpass the budget goal of \$2M. We received positive results and increased engagement across all giving, event, and engagement channels. Four new, engaging videos featuring BOEC programming, participants, and the Internship Program were added to the BOEC YouTube channel. Our signature fundraising events, Banff Mountain Film Festival, Fiesta for BOEC, and Tee It Up Golf Scramble, all had record-breaking years grossing over \$300K in event revenue. We are grateful to our generous in-kind partners and those who supported our online auction, a virtual event held in August with nearly 100 items raising \$25K.

Financial and Organizational

The Town of Breckenridge granted BOEC two 75year leases for BOEC's Administrative Headquarters and Wilderness Campus securing BOEC's future for many years to come. Close monitoring of revenue and expenses led to meeting budget goals for 2022-23. Significant progress was made on BOEC's five year strategic plan leading to organizational improvements and long term sustainability. BOEC is continually committed to the pursuit of equitable employee compensation, improving benefits, and training.


